Notes: All officers and archers **must** show their GNAS membership cards and failure to do so may lead to an archer being unable to participate.

This is a Record Status tournament and is therefore subject to Drug Control regulations. Failure to produce a specimen when requested by the appropriate authorised official will be treated as a POSITIVE RESULT. Authorisation to provide a specimen from a parent or guardian must be provided for ALL juniors on the form attached - this form must be returned with the entry form.

Longbow Archers must be members of GNAS.

All scores must be recorded in permanent blue or black medium; ie. not pencil or erasable ballpoint.

The Tournament Organiser will be responsible for Archers wearing correct dress, not the Judges. Archers asked not to shoot under dress regulation rules will not have their entry fee refunded.

Car parking will be at the discretion of Noak Hill car parking marshals.

All entries are accepted on the understanding that photography will be permitted on the day of the shoot. All persons taking photographs are asked to leave their name and address with the organiser.

Refreshments available all day

There will be drinks and hot food available all day (bacon sandwiches)

IMPORTANT NOTE FOR PARENTS.

All juniors are to be accompanied at all times by a parent or legal guardian. If a parent or legal guardian cannot accompany their child, it will be their responsibility to inform the organiser in writing that they have nominated another person to act on their behalf as a temporary guardian for the child. It will be the sole responsibility of the parent or legal guardian to vet the person they nominate to act as a temporary guardian and also to inform that person of their duties and liabilities whilst acting as a temporary guardian. :
