48.13 Any Other Business: Mrs M. Pearce (JRO) produced Junior Top Ten with points potential as per Constitution. A. Purser, P. Walker, Mrs L Howell, and Mrs Pearce will have access to dates of birth of juniors for selection information. (b) T. Ikel (SRO) published Top Ten. Southend had sent in a record claim for a Warwick shot on 24th July at their ground. Warwick record claims can only be claimed if shot at a Record Status Shoot (Fakenham Bowmen hold a Warwick Shoot in May), so in this particular case the record cannot be claimed. The claim form in question was made out as being the Club Record's Officer who was claiming the record for the Warwick, when in fact the Record's Officer should have put the archer's name in who was claiming the record. Scores for Warwick will only be accepted from November to March shot at the club on a Target Day or at an Open Shoot. Oakfeld congratulated C. Tricker on passing his Level III Coach. The Chairman also sent his congratulations from the County for the Level III Coach. (c) The Chairman read out a written report in the absence of the League Secretary stating that the Summer League was progressing well with the final match of the season to be shot on 15th September. There is an issue inasmuch as one club cannot host their match having lost the use of their ground on that day and the Away club cannot accommodate the match due to football on their ground. However, I have been trying to arrange for

the clubs to shoot on a neutral ground and are hopeful that this will be possible. The Andy Harris League (although not an official ECAA league) will start its 48th season in October with 41 teams from 24 clubs. There is a small entry fee for this league (£2.50 for the club's first team and £2 for subsequent teams) and over the past few years, the league has made a small profit. I would like to donate to the County a cheque for the sum of £50 with thanks to the archers of Essex for making this League so popular. This will be with the Treasurer within the next few days. The Chairman stated that the ground issue with the two clubs had been resolved. The matter regarding the donation will be held over until next meeting. (d) Membership is coming in for 2013/14. It is down by 150. (e) G. Sibley announced to the Meeting that he will be standing down as Secretary at the AGM. He came into the job as temporary, but in fact has been doing it for sixty years. It will be a gradual change over, and would suit someone who is younger. He stated that he felt that the time had come, and he would like to spend more time with his wife, Betty. He has also said that he will be reducing his judging duties. However, he will carry on with the Membership administration. The Meeting gave him a vote of thanks for all the years he has been County Secretary. He will be sadly missed. (f) County Indoor has Record Status

Being no other business the Chairman closed the Meeting at 21.10, thanked everyone for attending, and wished a safe journey home
