

**MINUTES OF ECAA COUNCIL MEETING HELD AT

75/11 Matters for Any Other Business – CCO Report. FITA Junior age group.

76/11 Minutes of last Meeting having been circulated were taken as read, seconded by R Hutchins (SEAC), accepted by the Meeting and signed by the Chairman.

77/11 Matters Arising – 67/11 Badges should be ready next week.

78/11 Chairman's Remarks – Judging at the Inter-county shoot Essex/Sussex. A wonderful day, the weather was good, but Essex did not win. All the archers shot extremely well but Sussex was a more powerful team this year.

79/11 Correspondence – (a) Paul Body applying to be Candidate Judge was agreed. (b) Missive from Office concerning 'Rio Dream'. Information on the website. Three Essex archers have already applied. (c) Southend club celebrate sixty years this year. (d) Details of Essex Archery Farm on website. (e) Deben considering a Junior section. (f) Change of Secretary for Chelmsford Tudor Rose – Mrs Angela Baharie, 3 Jeffrey Road, Gt Baddow, CM2 7BZ. 01245 478332. angela@baharie.com (g) Copy of letter from M Webb (Mayflower) concerning Affiliation Cards. (h) Message from a club shooting in a school hall that has been told that if they do not have a Coach within the club they cannot shoot on the school premises. What are the Coaching fraternity doing about it? (See CCO report under Any Other Business). (i) Clacton enquiring if a visitor who is a member of the Irish Amateur Archery Association and also a member of FITA can shoot with them. Replied that if their membership card is up to date, this is allowed. (j) Suffolk offering a Coaching Bursary for archers who are members of a Suffolk club. (k) Results of County Championships on website.

80/11 Report of SCAS Meeting 02.07.11 – Meeting cancelled and will take place later, possibly 30th July.

81/11 Clarification of claim for Warwick Rounds – Discussed at last meeting and will be updated on the Constitution. County will accept claims for record scores which have been shot at a Record Status shoot incorporating a Warwick round.

82/11 Records score claim - FITA introduced a reduced size face for the two shorter distances of the compound FITA round. All scores shot on the smaller faces should be sent to the relevant Records Officer. This will run for a year to see how it works out. Details will be on website. This will be brought to the AGM.

83/11 Calendar 2011/2012 – League Secretary asked on behalf of a club if the June league match date could be changed as it always falls on 'Father's Day'. Meeting felt that a change to another date would infringe on other tournaments that archers wished to attend, so nothing would be gained.

84/11 Any Other Business – (a) CCO Report - Level One course now full, names being taken for next Course. Level 2 Course being planned for 2012, grant applied for and will know more after 29th July 2011. County Coach Course is being looked into with a view to starting August 2012. Cost will be about £300 per person, will be open to other Counties and run over 12-months. Names, address, phone, email to Tony Ikel as soon as possible. Brought to my attention that schools and Councils are asking for clubs on Council property to produce Coaching certificates and CRB certificates or the club could be asked to vacate the property. Looking at how the Guild can help clubs that do not have a Level 1 coach. Leaders do not count as they are not GNAS. (b) R Frost will run a Leaders course in November with some places still available. (c) Junior record claim for an over-18 archer, shot in Malta. FITA accept junior scores up to the age of 21. This to be held over to November Meeting. (d) Proposed Candidate Judge Paul Body asked to assist judging at FITA. Entries coming in and Target List out next week. Very few Junior entrants but hoping for more. There are many FITA Star events at this time for the juniors and if they do not enter, may have to consider the FITA a senior shoot but this would stop new junior archers from 'cutting their teeth' on a straight-forward FITA tournament. (e) It may be necessary to increase tournament fees to cover cost of Record Status and Judges' new uniforms. (f) Essex juniors at Lilleshall last weekend brought home gold medals and broke records. (g) Daisy Clark shot 1294 Bristol 2. With three GB trips in the offing, two are fully funded but the third is not. Would the County consider helping with finance? Region lost account for a previous trip so no money was received. Secretary will look into this and ask them for help with the forthcoming trip.
