79/08 Matters arising – (72/08) Child Protection: Reply to an email sent by Chairman to GNAS, "Thank you for your email providing me with the information requested. As you are aware I have been liasing with Bill MacKay, Chairman of the GNAS Child Protection Steering Group, in relation to this and Bill will be responding direct to you. The Group have been and are still working very hard on the updated policy. It has been endorsed by the GNAS Board of Directors that once the updated policy has been distributed it will be mandatory for every GNAS Club to implement. I am sure you are aware that insurance also comes into this. The GNAS Child Protection Steering Group would not be able to withdraw anyone's membership from the Society – this would be outside their remit. The GNAS Child Protection Officer and the GNAS Child Protection Steering Group will work with all GNAS Clubs on the implementation of the updated policy. The GNAS Case Management Referral Panel is being set up and this must have the right people with the knowledge and expertise to enable them to sit on this panel. This will be a very professional panel. They will be dealing with all cases including child protection issues. The panel will make recommendations and these will be referred either back to the relevant body for action or referral to the GNAS for disciplinary action. It is important to follow the good guidelines within the Child Protection Policy at all times." J.Willson (Essex CPO) objected to the Chairman contacting GNAS stating it was his remit. He had dealt with the issue and would report under 82/08(t).

82/08 Reports from:

- a) TREASURER Final accounts for Clout Championships showing £116 profit. To those clubs sending affiliations for new members since May, do not worry if do not receive membership cards. The new SCAS Treasurer will not be able to process the affiliations until September.
- b) LEAGUE SECRETARY Two matches completed and Results and Table sent to clubs. One archer's score had to be discounted; he was not affiliated to the club for which he shot. Andy Harris entry form circulated by email, others will be posted by Secretary.
