Seconded A lkel (Oakfield) and agreed by the Meeting with one abstention. Suggested that a Short Metric round shooting to FITA rules be run alongside. Also ask that a 70/50m World Records Status be held on the day prior. Calendar will be looked at to see if this is viable.
