B. Miscellaneous

- i. The official programme for the European Championships held in Nottingham was received.
- ii. An email from AGB was received providing notification from World Archery that Bjorn Benson target faces are no longer licenced and therefore cannot be used at any World Archery record status tournaments with effect from 1 August 2016. They can still be used for club and UK record status events.
- iii. An email from Pam Hardy, secretary of Braintree Bowmen, was received detailing equipment that

was stolen from her car. This was widely circulated.

- iv. Letter received from AGB regarding the new fee structure, and also requesting clubs to respond by 31 May if they did not want their junior or disabled sections to be amalgamated into the main club. If there was no response this would be done automatically. MS sent out two reminders to all clubs before the deadline of 31 May.
- v. An email was shared regarding Lloyd Brown holding a coaching seminar at AGB on Saturday 4 June.
- vi. An email from James Howell was received, thanking the county for the donation towards the first leg of the 2016 European Youth Championships in Hungary. Also informing of selection for the second leg in Romania (which is fully funded).

80.16 Proposal from the ECAA Outdoor Summer League Secretary

The summery league secretary, Mrs M Hutchins proposed that the league rule 13 had an addition so that it reads:

'An archer may only represent the club through which their initial yearly fee is paid.'

This is an attempt to clarify which club members may represent throughout the league where members have changed clubs during the year.

This was discussed.

Proposed Marlene Hutchins, seconded Mike Pearce, voted unanimously to accept the amendment.

81.16 Any Other Business

a. Paul Clark brought in the trophy Daisy Clark won at the Archery World Cup leg 3. It was asked for congratulations to be passed on to Daisy. PC said thank you to the county for the support given to all juniors.

b. County Tournament entry fees

It had previously been requested that PC investigate the entry fee for other counties' tournaments in order to establish whether the Essex entry fees were reasonable. PC provided a list of fees paid to enter other Counties' championships. It was noted that the fees are all fairly similar and Essex is comparable.

c. County target shoot - Western round

MV noted that there were no medals presented for compound shooting this round and asked whether this was a policy. The Chairman confirmed that is no policy for this and that a gold should be awarded if there are entries, and others according to numbers entered.

d. European Championships

MS and DS attended the European champs in Nottingham. MS noted they had met a number of people they knew and that they were lucky with the weather. MS said that it was a very nice, well-run event. They saw the compound matches.

e. Team manager

Lesley Howell gave a report on the County Team Championships held in Lilleshall at the end of June. She confirmed that the compound men's team had come 3rd, and although the official results are not yet available, it was calculated that the recurve men had come 4th. There were 3 archers debuting for the County and everyone shot really well considering conditions Everyone did well.

Lesley Howell informed the meeting that there is a match planned on 7 August against Kent. Unfortunately, she hasn't received enough scores from archers for the event and therefore doesn't think we should go given this. LH noted that the date provided by Kent clashes with a league match and the Junior UK Masters. This was discussed and agreed that we should postpone the match to a more suitable date.

LH confirmed that for the SCAS Team event in September she has provisionally booked adult recurve and compound teams, and junior recurve and compound teams. A maximum of 4 teams are allowed initially. It was agreed if more space was available a longbow team would be entered.

Cut-off date to receive scores for SCAS team shoot was proposed to be moved from 22 July to 25 July to allow archers to include the County WA 1440 in their scores if desired.

Anna King proposed, Marion Saville seconded. approved unanimously.

Senior records officer

Anna King proposed 6 new records to be ratified (details below). These were agreed.

g. Records from Junior records officer

The Junior records officer presented 18 scores new records to be ratified (details below). These were agreed.

h. County bosses

Arthur Toy provided a report on the county's bosses and stands. He confirmed that these had been sorted on the Friday before the Target championships and the team had put the best centres on that were available. However new ones are required. After discussion, it was confirmed that 9 new centres were required and the cheapest way to buy this number is to buy as a target without legs. AT also confirmed that a number of stands need parts replacing and suggested that the clips are changed to L brackets where necessary as the current rebating cannot be replicated.

It was proposed to buy two bosses and stand replacement parts as needed.

Proposed Anna King, seconded Lesley Howell, accepted unanimously.
