Line to read:
"NB This process will be in line with published GNAS and SCAS Policies and in conjunction with the published ECAA Disciplinary Policy".

(iii) To amend the election of President as follows:

Page 3, Item 5, President.
Insert - Paragraph 3, line to read:
"Individuals elected to this post shall not hold additional posts on the Executive of the County. In the event that an individual already holds a post on the Executive, the individual will automatically stand down from the Executive post at the Annual General Meeting of Presidential election. This does not apply if the preheld post is Non-Executive".
Proposed by A Purser (Chairman), seconded Mrs M Pearce (General Member). Motion carried with one abstention.
(iv) To amend the election of Vice President as follows:

Page 3, Item 5, Vice President.
Insert - Paragraph 3, line to read:
"Individuals elected to this post shall not hold additional posts on the Executive of the County. In the event that an individual already holds a post on the Executive, the individual will automatically stand down from the Executive post at the Annual General Meeting of Vice Presidential election. This does not apply if the post is Non-Executive".
